The Society, established in 1904, publishes a wide range of Records volumes in which many kinds of registers, chronicles, letters and diaries relating to individuals and ecclesiastical institutions in the British Isles are preserved for posterity and made available to a general readership. Over ninety volumes have been published and they form a unique collection of primary source material indispensable to all those with an interest in the history of Catholic dioceses, parishes, religious communities, schools and colleges. The Society has also published a number of Monographs dealing with particular topics or with Catholic individuals prominent in public life. The half-yearly journal, *British Catholic History*, publishes descriptive and interpretative articles on political, scientific, cultural and sociological history to place clerical and lay British Catholics in their national context during the centuries from the Reformation to the recent past.

The CRS holds an annual 3-day residential conference and local day conferences attended by an interdenominational, international, academic and non-academic audience with a wide spectrum of interests.

Details of the annual conference are included in the May edition of *British Catholic History*.
